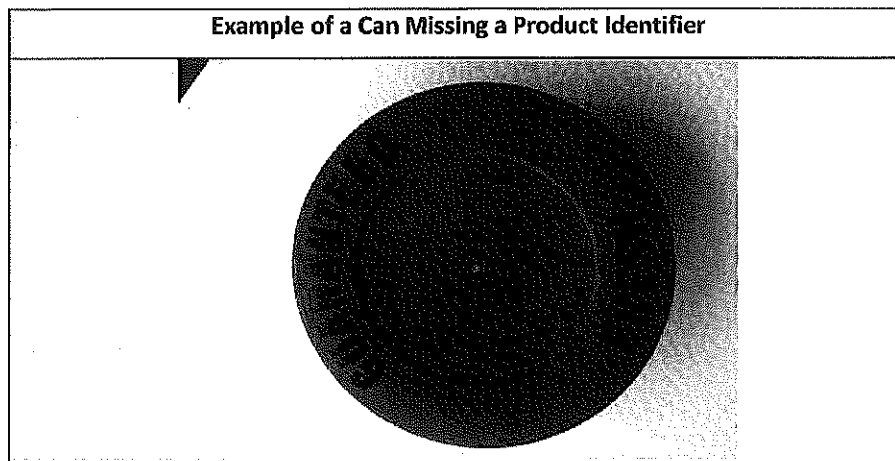
**No. 2 Immediate Action for USSTC Products on Appendix B**

AGDC is requesting you take the following action immediately on the USSTC products listed in Appendix B:

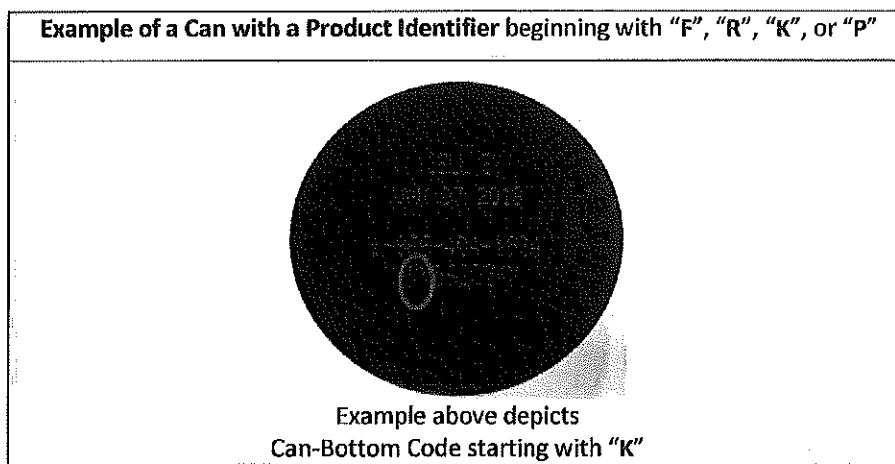
- Check bottom of the can for a missing product identifier or the product identifiers listed below.

  - If there is a product identifier beginning with any letter besides "F", "R", "K", or "P", then remerchandise and make available for sale.
